If you or your child are still unsure as to whether they wish to take part in the visits, we would still like you to attend the meeting before making a final decision.

We are also inviting the children to attend so please bring them along to ask any questions they may have.

The total cost of the visit is £45.00 which includes transport, accommodation and meals. If you have confirmed that your child is to take part in either of the visits please return the consent form below and enclose a deposit of £10.00 by the end of January 2017. (Cash or cheque made payable to Meadow Lane Infant School).

We have been collating your preferences for the dates of the visits and all those who selected a specific date will be able to attend on their choice of date. If you stated that your child could attend on either dates, we will confirm this with you once all the deposits have been paid. We will require the final balance of £35.00 by Thursday 31 March 2017 (you may pay us in instalments if this is easier).
